

## **DSWD DROMIC Report on the Fire Incident in Brgy. Poblacion Ilaya, Lambunao, Iloilo**

31 May 2024, 6AM

### **I. Situation Overview**

On 06 May 2024 at around 10:29 PM, a fire incident occurred at Brgy. Poblacion Ilaya, Lambunao, Iloilo. The fire was declared out at around 11:00 PM.

Relative to the incident, the DSWD through its Field Office in Region VI, together with the Local Government Unit (LGU) of Lambunao, Iloilo, provided relief assistance to support the immediate needs of the affected family.

**One (1) family** or **four (4) persons** were affected in **Brgy. Poblacion Ilaya, Lambunao, Iloilo** (see Annex A).

**One (1) family** or **four (4) persons** temporarily stayed with their relatives (see Annex B).

### **IV. Damaged Houses**

**One (1) house** was partially damaged in **Brgy. Poblacion Ilaya, Lambunao, Iloilo** (see Annex C).

### **V. Cost of Humanitarian Assistance Provided**

A total of **₱8,074.00** worth of assistance was provided to the affected family composed of **₱7,184.00** from **DSWD** and **₱890.00** from the **Local Government Unit (LGU)** (see Annex D).
