I. Situation Overview

On 12 April 2024 at around 2:20 PM, a fire incident occurred at Mabini Street, Brgy. Poblacion, Kalibo, Aklan. The fire was declared out at around 3:00 PM.

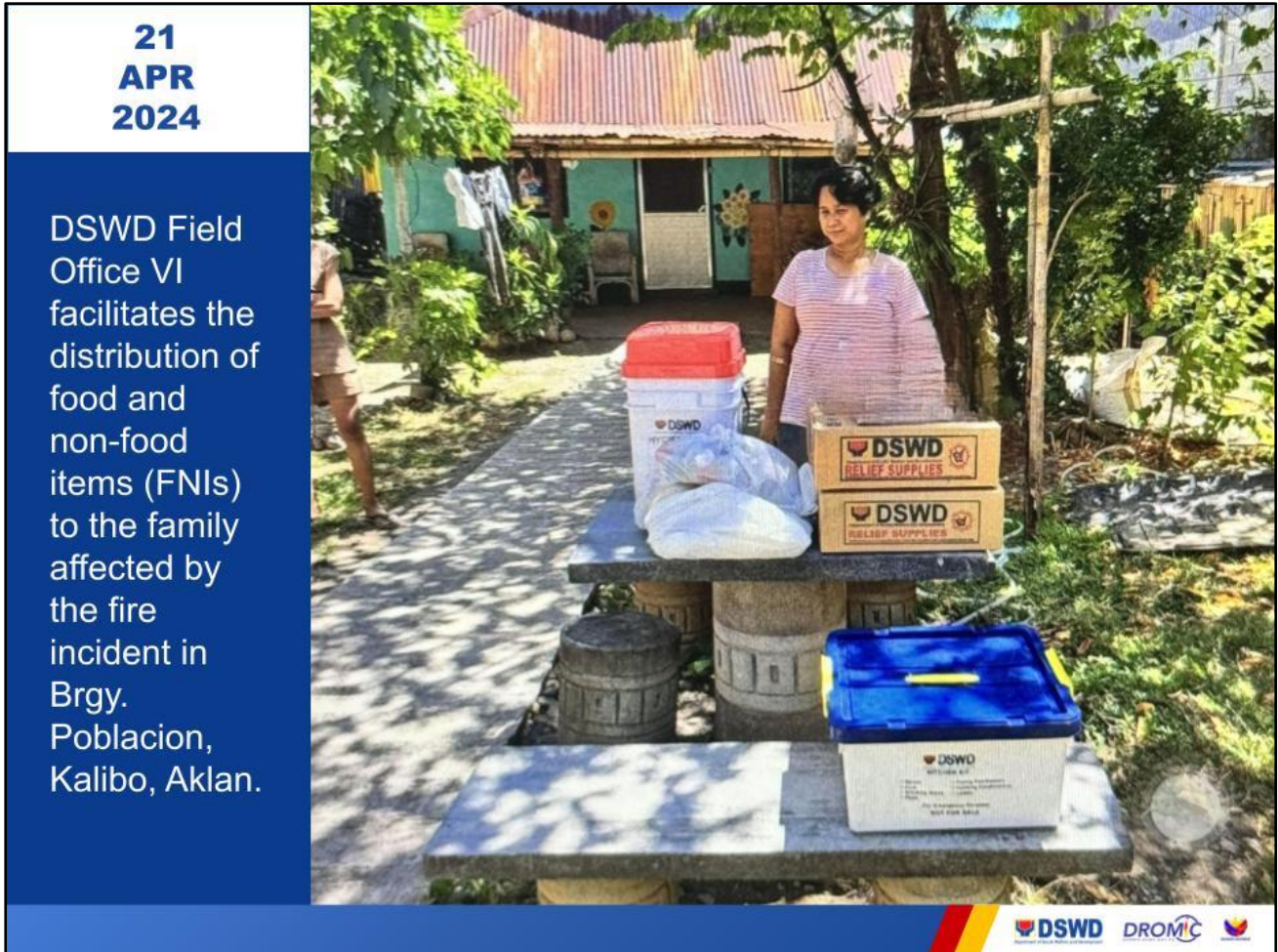
