

## **DSWD DROMIC Report on the Fire Incident in Brgy. Sacpil, Conner, Apayao**

### **I. Situation Overview**

On 24 March 2024 at around 2:50 PM, a fire incident occurred at Purok 4, Sitio Simut in Brgy. Sacpil, Conner, Apayao.

A total of **three (3) families** or **11 persons** were affected in **Brgy. Sacpil, Conner, Apayao** (see Annex A).

### **III. Status of Displaced Population**

#### **Outside Evacuation Center**

A total of **three (3) families** or **11 persons** temporarily stayed with their relatives or friends (see Annex B).

### **IV. Damaged Houses**

**One (1) house** was **totally damaged** in **Brgy. Sacpil, Conner, Apayao** (see Annex C).

### **V. Cost of Humanitarian Assistance Provided**

A total of **₱94,361.85** worth of assistance was provided to the affected families; of which, **₱56,861.85** from **DSWD** and **₱37,500.00** from the **Local Government Unit (LGU)** (see Annex D).

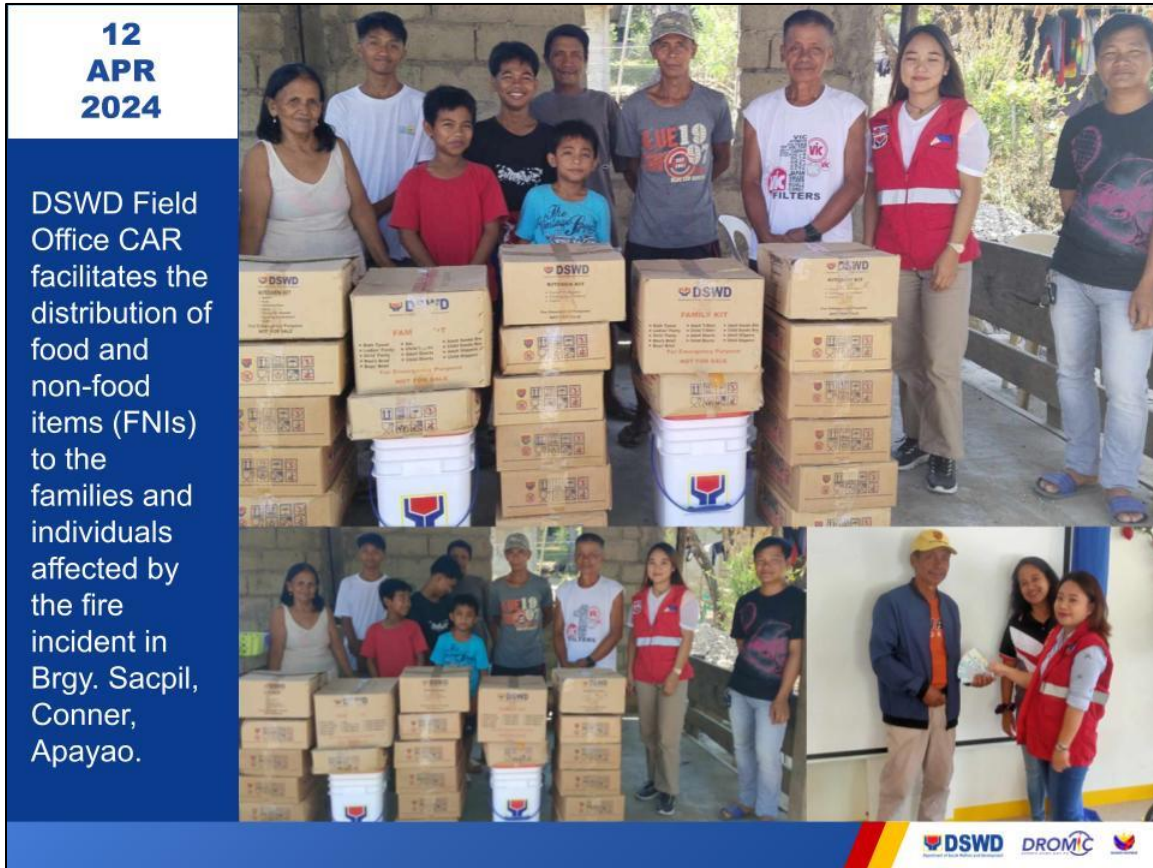
