





# DSWD DROMIC Report on the Fire Incident in Brgy. Sta. Maria, Flora, Apayao

27 May 2024, 6PM

#### I. Situation Overview

On 20 April 2024 at around 9:16 AM, a fire incident occurred at Purok 7, Brgy. Sta. Maria, Flora, Apayao. The result of the validation indicated that one (1) was completely destroyed. The affected individual, who is living alone, sought temporary shelter with his relatives in the nearby locality.

In response, the DSWD through its Field Office in Cordillera Administrative Region, together with the Local Government Unit (LGU) of Apayao, provided relief and financial assistance to support the immediate needs of the affected individual.
