

DSWD DROMIC Report on the Fire Incident in Brgy. Taculing, Bacolod City, Negros Occidental

03 May 2024, 6AM

I. Situation Overview

On 08 April 2024 at around 2:00 PM, a fire incident occurred in Brgy. Taculing, Bacolod City, Negros Occidental. The fire was declared out at around 3:15 PM.

One (1) family or four (4) persons were affected in **Brgy. Taculing, Bacolod City, Negros Occidental** (see Annex A).

Outside Evacuation Center

One (1) family or four (4) persons temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Taculing, Bacolod City, Negros Occidental** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱11,218.00** worth of assistance was provided to the affected family; of which, **₱6,928.00** from **DSWD** and **₱4,290.00** from the **Local Government Unit (LGU)** (see Annex D).
