





# DSWD DROMIC Report on the Fire Incident in Brgy. Tico, Panay, Capiz

22 May 2024, 6PM

#### I. Situation Overview

On 28 April 2024 at around 11:30 PM, a fire incident occurred in Sitio Pangpang, Brgy. Tico, Panay, Capiz. The fire was declared out at around 2:00 AM.

In response, the DSWD through its Field Office in Region VI, provided relief assistance to support the immediate needs of the affected family.
