I. Situation Overview

On 01 May 2024 at around 12:15 PM, a fire incident occurred in Brgy. Tulahong, Maasin, Iloilo. The fire was declared out at around 12:45 PM.

Outside Evacuation Center

One (1) family or six (6) persons temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Tulahong, Maasin, Iloilo** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱12,428.00** worth of assistance was provided to the affected families; of which, **₱12,016.00** from **DSWD** and **₱412.00** from the **Local Government Unit (LGU)** (see Annex D).
