## DSWD DROMIC Report on the Fire Incident in Brgy. Velasco, Lemery, Iloilo

30 May 2024, 6AM

### I. Situation Overview

On 23 April 2024 at around 9:15 AM, a fire incident occurred in Brgy. Velasco, Lemery, Iloilo. The fire was declared out at around 10:00 AM.

**One (1) family** or **five (5) persons** were affected in **Brgy. Velasco, Lemery, Iloilo** (see Annex A).

### III. Status of Displaced Population

#### Outside Evacuation Center

**One (1) family** or **five (5) persons** temporarily stayed with their relatives or friends (see Annex B).

### IV. Damaged Houses

**One (1) house** was **totally damaged** in **Brgy. Velasco, Lemery, Iloilo** (see Annex C).

### V. Cost of Humanitarian Assistance Provided

A total of **₱12,086.00** worth of assistance was provided to the affected families; of which, **₱7,086.00** from **DSWD** and **₱5,000.00** from the **Local Government Unit (LGU)** (see Annex D).

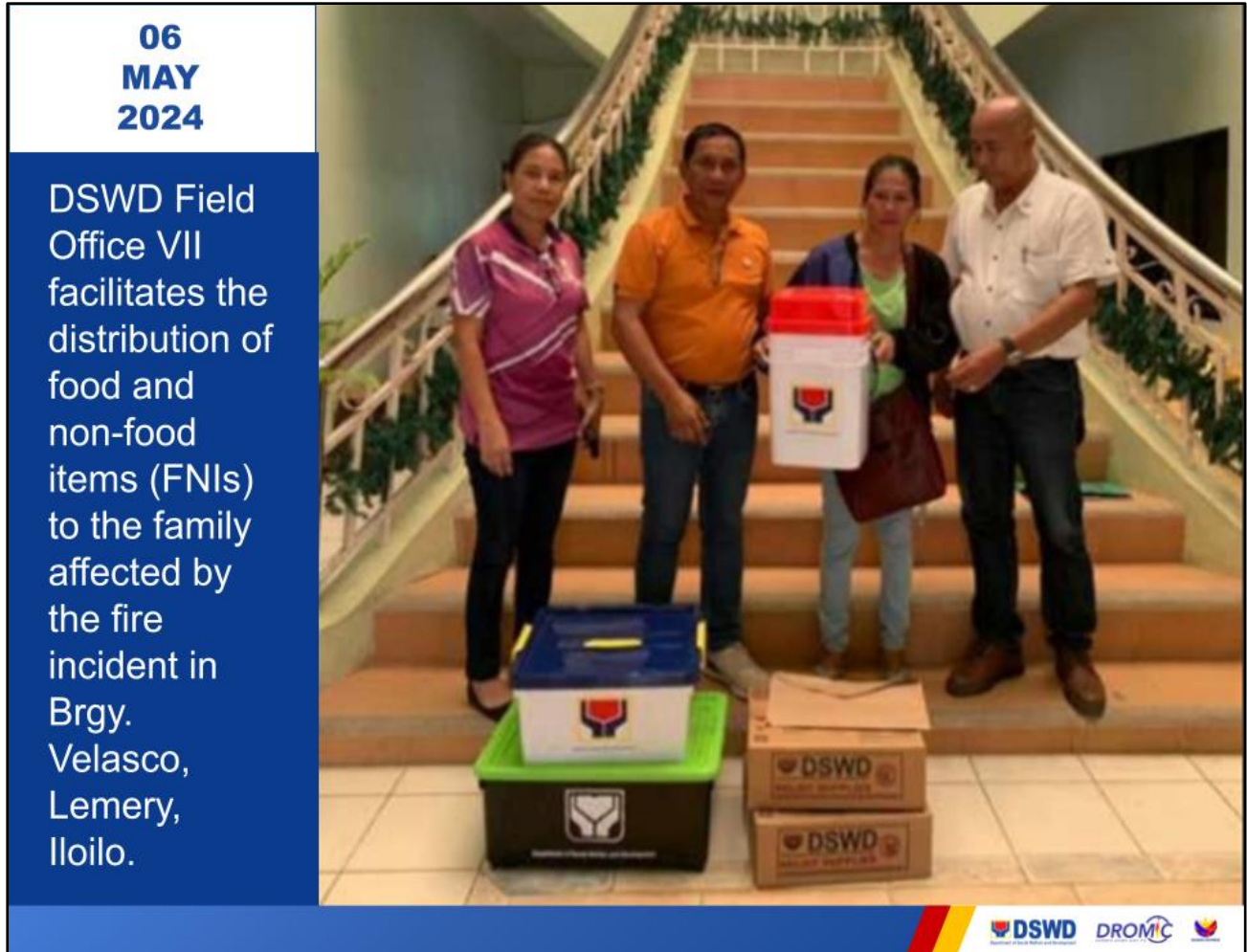
