I. Situation Overview

On 14 April 2024 at around 10:20 PM, a fire incident occurred in Brgy. Zona Sur, Banate, Iloilo. The fire was declared out at around 11:00 PM.

One (1) family or six (6) persons temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house was partially damaged in Brgy. Zona Sur, Banate, Iloilo (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱11,918.00** worth of assistance was provided to the affected families; of which, **₱6,918.00** from **DSWD** and **₱5,000.00** from the **Local Government Unit (LGU)** (see Annex D).
