I. Situation Overview

On 04 May 2024 at around 11:33 PM, a fire incident occurred in Brgy. Maribong, Lambunao, Iloilo. The fire was declared out at around 12:00 AM

One (1) family or two (2) persons were affected in Brgy. Maribong, Lambunao, Iloilo (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or **two (5) persons** stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Maribong, Lambunao, Iloilo** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱13,144.00 worth of assistance was provided to the affected family; of which, ₱7,184.00 from DSWD and ₱5,960.00 from the Local Government Unit (LGU) (see Annex D).
