On 04 May 2024 at around 11:33 PM, a fire incident occurred in Brgy. Maribong, Lambunao, Iloilo. The fire was declared out at around 12:00 AM

One (1) house was **totally damaged** in **Brgy. Maribong, Lambunao, Iloilo** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱13,144.00** worth of assistance was provided to the affected family; of which, **₱7,184.00** from **DSWD** and **₱5,960.00** from the **Local Government Unit (LGU)** (see Annex D).
