

DSWD DROMIC Report on the Gas Poisoning Incident in Brgy. Magsaysay Hill, Bambang, Nueva Vizcaya

21 May 2024, 6PM

I. Situation Overview

On 06 May 2024 at around 10:00 AM, a gas poisoning incident occurred inside a suspected mining tunnel at Brgy. Magsaysay Hill, Bambang, Nueva Vizcaya that resulted in several casualties and lead to the displacement of families and persons within the 30-meter radius of the affected site.

II. Status of Affected Areas and Population

A total of **17 families** or **64 persons** were affected in **Brgy. Magsaysay Hill, Bambang, Nueva Vizcaya** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

A total of **14 families** or **60 persons** temporarily stayed with their neighbors (see Annex B).

IV. Cost of Humanitarian Assistance Provided

A total of **₱54,869.12** worth of assistance was provided to the affected families; of which, **₱46,469.12** from **DSWD** and **₱8,400.00** from the **Local Government Unit (LGU)** (see Annex C).
