

# DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Alitaya, Mangaldan, Pangasinan

14 June 2024, 6PM

## I. Situation Overview

On 04 May 2024 at around 12:22 PM, a fire incident occurred in Brgy. Alitaya, Mangaldan, Pangasinan.

In response, DSWD through its Field Office in Region I together with the Local Government Unit (LGU) of Mangaldan, Pangasinan promptly provided relief assistance to support the immediate needs of the affected families and individuals.

A total of **two (2) families** or **four (4) persons** were affected in **Brgy. Alitaya, Mangaldan, Pangasinan** (see Annex A).

There are **two (2) families** or **four (4) persons** temporarily staying with their relatives (see Annex B).

## IV. Damaged Houses

**One (1) house** was **totally damaged** in **Brgy. Alitaya, Mangaldan, Pangasinan** (see Annex C).

## V. Cost of Humanitarian Assistance Provided

A total of **₱22,916.30** worth of assistance was provided to the affected families composed of **₱12,916.30** from **DSWD** and **₱10,000.00** from the **Local Government Unit (LGU)** (see Annex D).
