

## **DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Ibo, Danao City, Cebu**

30 January 2025, 6AM

### **I. Situation Overview**

On 16 January 2024 at around 6AM, a fire incident occurred in Brgy. Ibo, Danao City, Cebu. The fire was declared out at around 7:30 AM.

Relative to the incident, the DSWD through its Field Office in Region VII, together with the Local Government Unit (LGU) of Danao City, provided relief augmentation to support the immediate needs of the affected families and individuals.

A total of **two (2) families** or **nine (9) persons** were affected in **Brgy. Ibo, Danao City, Cebu** (see Annex A).

### **III. Status of Displaced Population**

A total of **two (2) families** or **nine (9) persons** temporarily stayed with their relatives or friends (see Annex B).

### **IV. Damaged Houses**

**One (1) house** was **totally damaged** in **Brgy. Ibo, Danao City, Cebu** (see Annex C).

### **V. Cost of Humanitarian Assistance Provided**

A total of **₱20,647.00** worth of assistance was provided to the affected families composed of **₱18,147.00** from **DSWD** and **₱2,500.00** from the **Local Government Unit (LGU)** (see Annex D).
