





DSWD DROMIC Terminal Report on the Fire Incident in Brgy. MRR-Queen of Peace, Baguio City

I. Situation Overview

On 13 April 2024 at around 4:00 AM, a fire incident occurred at Purok 3, Brgy. MRR-Queen of Peace, Baguio City, and was declared fire out at around 8:00 AM.

A total of **70 families** or **112 persons** were affected in **Brgy. MRR-Queen of Peace**, **Baguio City** (see Annex A).

III. Status of Displaced Population

Total Displaced Population

A total of **70 families** or **112 persons** were displaced in **Brgy. MRR-Queen of Peace, Baguio City** (see Annex B).

IV. Damaged Houses

A total of seven (7) houses were damaged; of which, six (6) are totally damaged and one (1) partially damaged in Brgy. MRR-Queen of Peace, Baguio City (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **P2,098,681.50** worth of assistance was provided to the affected families; of which, **P1,436,481.50** from **DSWD**, **P532,500.00** from the **Local Government Unit (LGU)** and **P129,700.00** from **other Partners** (see Annex D).
