I. Situation Overview

On 12 May 2024 at around 3:30 PM, a fire incident occurred in Brgy. Masi, Santa Teresita, Cagayan.

One (1) family or four (4) persons were affected in Brgy. Masi, Santa Teresita, Cagayan (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or **four (4) persons** are temporarily staying with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was **partially damaged** in **Brgy. Masi, Santa Teresita, Cagayan** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱23,093.00** worth of assistance was provided to the affected family; of which, **₱15,793.00** from **DSWD** and **₱7,300.00** from the **Local Government Unit (LGU)** (see Annex D).
