

DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Rugsuanan, Vigan City, Ilocos Sur

08 May 2024, 6AM

I. Situation Overview

On April 30, 2024, around 9:56 AM, a fire incident caused by faulty electrical wiring occurred in Brgy. Rugsuanan, Vigan City, Ilocos Sur. The displaced family is currently seeking temporary shelter with their relatives while their house is being reconstructed.

In response to the incident, the Department of Social Welfare and Development (DSWD) through its Field Office in Region I, along with the Local Government Unit (LGU) of Vigan City, provided relief and financial assistance to support the immediate needs of the affected family.

Furthermore, the LGU will continue to address the further needs of the family. Hence, the termination of this report.

One (1) family or five (5) persons were affected in **Brgy. Rugsuanan, Vigan City, Ilocos Sur** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or five (5) persons are temporarily staying with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Rugsuanan, Vigan City, Ilocos Sur** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱24,957.26** worth of assistance was provided to the affected families composed of **₱22,157.26** from the **DSWD** and **₱2,800.00** from the **Local Government Unit (LGU)** (see Annex D).
