

# DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Budlasan, Canlaon City, Negros Oriental

30 January 2025, 6AM

## I. Situation Overview

On 14 March 2024 at around 2:55 PM, a fire incident occurred in Brgy. Budlasan, Canlaon City, Negros Oriental and it was declared fire out at around 3:25 PM.

In response, the DSWD through its Field Office VII, together with the Local Government Unit (LGU) of Canlaon City provided relief assistance to support the immediate needs of the affected family.

One (1) family or four (4) persons were affected in Brgy. Budlasan, Canlaon City, Negros Oriental (see Annex A).

One (1) family or four (4) persons temporarily stayed with their relatives or friends (see Annex B).

## IV. Damaged Houses

One (1) house was totally damaged in Brgy. Budlasan, Canlaon City, Negros Oriental (see Annex C).

## V. Cost of Humanitarian Assistance Provided

A total of ₱15,551.00 worth of assistance was provided to the affected family composed of ₱7,551.00 from DSWD and ₱8,000.00 from the Local Government Unit (LGU) (see Annex D).
