I. Situation Overview

On 09 June 2024 at around 8:46 AM, a fire incident occurred at 2205 Elias St., Brgy. 351, Sta. Cruz, Manila City. The fire was declared out at around 10:01 AM.

A total of **77 families** or **265 persons** are affected in **Brgy. 351, Sta. Cruz, Manila City** (see Annex A).

III. Status of Displaced Population

Inside Evacuation Center

There are **77 families** or **265 persons** currently taking temporary shelter at the **Brgy**. **351 Covered court** in **Brgy**. **Sta**. **Cruz**, **Manila City** (see Annex B).

IV. Damaged Houses

A total of 28 houses were damaged; of which, 20 are totally damaged and eight (8) are partially damaged in Brgy. 351, Sta. Cruz, Manila City (see Annex C).
