I. Situation Overview

On 26 May 2024 at around 11:00 AM, a fire incident occurred in Brgy. Butason II, Tabango, Leyte.

One (1) family or five (5) persons are affected in Brgy. Butason II, Tabango, Leyte (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or five (5) persons temporarily staying with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house was totally damaged in Brgy. Butason II, Tabango, Leyte (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **P8,226.00** worth of assistance was provided by **DSWD** to the affected family (see Annex D).

20 June 2024	 DSWD FO VIII coordinated with the Municipal Social Welfare and Development Office (MSWDO) and Municipal Disaster Risk Reduction and Management Office (MDRRMO) of Tabango for the conduct of intake interviews, assessment, validation and profiling of the affected family and individuals. DSWD FO VIII endorsed the affected family for further financial assistance through the Assistance to Individuals in Crisis Situation (AICS). DSWD FO VIII closely coordinates with the affected LGU and other concerned offices for significant updates and further augmentation request.
