

## DSWD DROMIC Report #1 on the Fire Incident in Brgy. Dolho, Bato, Leyte as of 20 June 2024, 6PM

### I. Situation Overview

On 19 June 2024 at around 1:50 AM, a fire incident occurred in Brgy. Dolho, Bato, Leyte.

### II. Status of Affected Areas and Population

A total of **33 families** or **133 persons** are affected in **Brgy. Dolho, Bato, Leyte** (see Annex A).

### III. Status of Displaced Population

#### Outside Evacuation Center

There are **33 families** or **133 persons** temporarily staying with their relatives or friends (see Annex B).

### IV. Damaged Houses

A total of **31 houses** were damaged; of which, **27** are **totally damaged** and **four (4)** are **partially damaged** in **Brgy. Dolho, Bato, Leyte** (see Annex C).

### V. Cost of Humanitarian Assistance Provided

A total of **₱316,848.10** worth of assistance from **DSWD** was provided to the affected families
