
DSWD DROMIC Report #1 on the Fire Incident in Brgy. Rivera, San Juan City

as of 02 June 2024, 6PM

I. Situation Overview

On 31 May 2024 at around 8:10 PM, a fire incident occurred at Olazo Street, Brgy. Rivera, San Juan City. The fire was declared out at around 09:00 PM.

II. Status of Affected Areas and Population

A total of **119 families** or **416 persons** are affected in **Brgy. Rivera, San Juan City** (see Annex A).

III. Status of Displaced Population

a. Inside Evacuation Center

There are **58 families** or **210 persons** currently taking temporary shelter in **two (2) evacuation centers** in **Brgy. Rivera, San Juan City** (see Annex B).

b. Outside Evacuation Center

There are **61 families** or **201 persons** temporarily staying with their relatives or friends (see Annex C).

c. Total Displaced Population

There are **119 families** or **411 persons** displaced in **Brgy. Rivera, San Juan City** (see Annex D).

IV. Damaged Houses

A total of **113 houses** were damaged; of which, **86** are **totally damaged** and **27** are **partially damaged** in **Brgy. Rivera, San Juan City** (see Annex E).

V. Cost of Humanitarian Assistance Provided

A total of **₱240,811.97** worth of assistance from **DSWD** was provided to the affected families. (see Annex F).
