I. Situation Overview

On 09 May 2024 at around 5:30 PM, a Whirlwind Incident occurred in Brgy. San Marcelino, Balungao, Pangasinan.

II. Status of Affected Areas and Population

A total of **two (2) families** or **nine (9) persons** are affected in **Brgy. San Marcelino, Balungao, Pangasinan** (see Annex A).

III. Damaged Houses

Two (2) houses were **partially damaged** in **Brgy. San Marcelino, Balungao, Pangasinan** (see Annex B).

IV. Cost of Humanitarian Assistance Provided

A total of **₱32,328.28** worth of assistance was provided to the affected families; of which, **₱16,808.28** from **DSWD** and **₱15,520.00** from the **Local Government Unit (LGU)** (see Annex C).
