

DSWD DROMIC Report #2 on the Fire Incident in Brgy. Lapasan, Cagayan de Oro City, Misamis Oriental

as of 02 June 2024, 6AM

I. Situation Overview

On 31 May 2024 at around 10:44 AM, a fire incident occurred at San Lazaro, Brgy. Lapasan, Cagayan de Oro City, Misamis Oriental. The fire was declared out at around 4:36 AM the next day.

II. Status of Affected Areas and Population

A total of **87 families** or **303 persons** are affected in **Brgy. Lapasan, Cagayan de Oro City, Misamis Oriental** (see Annex A).

III. Status of Displaced Population

Inside Evacuation Center

There are **87 families** or **303 persons** are currently taking temporary shelter at the **Lapaz-1 Covered Court** (see Annex B).

IV. Damaged Houses

A total of **43 houses** were damaged; of which, **40** are **totally damaged** and **three (3)** are **partially damaged** in **Brgy. Lapasan, Cagayan de Oro City, Misamis Oriental** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱75,250.00** worth of assistance was provided to the affected families from the **Local Government Unit (LGU)** (see Annex D).
