

DSWD DROMIC Report #2 on the Fire Incident in City Proper, Iloilo City as of 18 June 2024, 6AM

I. Situation Overview

On 17 June 2024 at around 2:00 AM, a fire incident occurred on the boundary of Brgy. Tanza Bonifacio and Brgy. Rizal Estantzuela, City Proper, Iloilo City. The fire was declared out at around 4:37 AM.

II. Status of Affected Areas and Population

A total of **85 families** or **290 persons** are affected in **City Proper, Iloilo City** (see Annex A).

III. Status of Displaced Population

Inside Evacuation Center

There are **85 families** or **290 persons** currently taking temporary shelter in **two (2) evacuation centers** in **City Proper, Iloilo City** (see Annex B).

IV. Damaged Houses

A total of **45 houses** were damaged; of which, **33** are **totally damaged** and **12** are **partially damaged** in **City Proper, Iloilo City** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱533,194.80** worth of assistance was provided by **DSWD** to the affected families (see Annex D).
