I. Situation Overview

On 29 April 2024 at around 9:15 PM, a fire incident occurred at Sitio Uyhon, Brgy. Amganad, Banaue, Ifugao.

A total of **two (2) families** or **eight (8) persons** were affected in **Brgy. Amganad, Banaue, Ifugao** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

A total of **two (2) families** or **eight (8) persons** temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

A total of **two (2) houses** were **totally damaged** in **Brgy. Amganad, Banaue, Ifugao** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱43,782.20** worth of assistance was provided to the affected families; of which, **₱19,782.20** from **DSWD** and **₱24,000.00** from the **Local Government Unit (LGU)** (see Annex D).
