I. Situation Overview

On 17 May 2024 at around 9:15 AM, a fire incident occurred at Sitio Albanga, Brgy. Anahawan, Bato, Leyte. The fire was declared out at around 9:30 AM.

One (1) family or four (4) persons temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house was totally damaged in Brgy. Anahawan, Bato, Leyte (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱18,346.10 worth of assistance was provided by **DSWD** to the affected family (see Annex D).
