I. Situation Overview

On 08 May 2024 at around 11:00 AM, a fire incident occurred at Sitio Batwag, Brgy. Bangaan, Banaue, Ifugao.

One (1) family or two (2) persons were affected in Brgy. Bangaan, Banaue, Ifugao (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or **two (2) persons** are temporarily staying with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Bangaan, Banaue, Ifugao** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱19,205.45 worth of assistance was provided to the affected family; of which, ₱9,205.45 from DSWD and ₱10,000.00 from the Local Government Unit (LGU) (see Annex D).
