

DSWD DROMIC Report on the Fire Incident in Brgy. Cantariwis, Tolosa, Leyte

09 June 2024, 6PM

I. Situation Overview

On 18 May 2024 at around 3:00 AM, a fire incident occurred in Brgy. Cantariwis, Tolosa, Leyte.

In response, the DSWD through its Field Office in Region VIII, promptly provided relief and financial assistance to support the immediate needs of the affected family.

One (1) family or five (5) persons temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Cantariwis, Tolosa, Leyte** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱18,756.00** worth of assistance was provided by **DSWD** to the affected family (see Annex D).
