

DSWD DROMIC Report on the Fire Incident in Brgy. Lawi, Jordan, Guimaras

20 June 2024, 6PM

I. Situation Overview

On 12 April 2024 at around 7:30 AM, a fire incident occurred in Brgy. Poblacion, Jordan, Guimaras. The fire was declared out at around 8:40 AM.

One (1) family or four (4) persons were affected in **Brgy. Poblacion, Jordan, Guimaras** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or four (4) persons temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Poblacion, Jordan, Guimaras** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱10,796.00** worth of assistance was provided to the affected families; of which, **₱7,796.00** from **DSWD** and **₱3,000.00** from the **Local Government Unit (LGU)** (see Annex D).
