I. Situation Overview

On 06 May 2024, a fire incident occurred in Brgy. Malabantias, Angeles City, Pampanga.

A total of **four (4) families** or **20 persons** were affected in **Brgy. Malabantias, Angeles City, Pampanga** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

A total of **four (4) families** or **20 persons** stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

A total of **four (4) houses** were damaged: of which, **two (2)** are **totally damaged** and **two (2)** are **partially damaged** in **Brgy. Malabantias, Angeles City, Pampanga** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱34,705.12** worth of assistance was provided to the affected family; of which, **₱29,749.12** from **DSWD** and **₱4,956.00** from the **Local Government Unit (LGU)** (see Annex D).
