### I. Situation Overview

On 13 April 2024 at around 8:35 AM, a fire incident occurred at in Brgy. Poblacion, Jordan, Guimaras. The fire was declared out at around 9:45 AM.

**One (1) family or three (3) persons** temporarily stayed with their relatives or friends (see Annex B).

### IV. Damaged Houses

**One (1) house** was **totally damaged** in **Brgy. Poblacion, Jordan, Guimaras** (see Annex C).

### V. Cost of Humanitarian Assistance Provided

A total of **₱10,796.00** worth of assistance was provided to the affected family; of which, **₱7,796.00** from **DSWD** and **₱3,000.00** from the **Local Government Unit (LGU)** (see Annex D).
