I. Situation Overview

On 31 March 2024 at around 10AM, a fire incident occurred at Sitio Chaggiw, Brgy. Pula, Banaue, Ifugao.

One (1) family or **seven (7) persons** were affected in **Brgy. Pula, Banaue, Ifugao** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or **seven (7) persons** temporarily staying with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Pula, Banaue, Ifugao** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱19,891.10** worth of assistance was provided to the affected family; of which, **₱9,891.10** from **DSWD** and **₱10,000.00** from the **Local Government Unit (LGU)** (see Annex D).
