

DSWD DROMIC Report on the Fire Incident in Brgy. San Francisco, City of San Fernando, La Union

09 June 2024, 6PM

I. Situation Overview

On 30 April 2024 at around 10:04 AM, a fire incident occurred at Purok 3, Brgy. San Francisco, City of San Fernando, La Union.

Relative to the incident, the DSWD through its Field Office in Region I, together with the Local Government Unit (LGU) of San Fernando City, provided relief and financial assistance to support the immediate needs of the affected families and individuals.

II. Status of Affected Areas and Population

A total of **six (6) families** or **19 persons** were affected in **Brgy. San Francisco, City of Fernando, La Union** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

A total of **five (5) families** or **15 persons** temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

A total of **four (4) houses** were damaged; of which, **three (3)** are **totally damaged** and **one (1)** are **partially damaged** in **Brgy. San Francisco, City of Fernando, La Union** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱100,171.89** worth of assistance was provided to the affected families composed of **₱74,379.89** from **DSWD** and **₱25,792.00** from the **Local Government Unit (LGU)** (see Annex D).
