





DSWD DROMIC Report on the Fire Incident in Brgy. Telegrafo, Tolosa, Leyte

09 June 2024, 6PM

I. Situation Overview

On 23 May 2024 at around 2:30 PM, a fire incident occurred in Brgy. Telegrafo, Tolosa, Leyte. In response, the DSWD through its Field Office in Region VIII, together with the Local Government Unit (LGU) of Tolosa, promptly provided relief and financial assistance to support the immediate needs of the affected family.

One (1) house was totally damaged in Brgy. Telegrafo, Tolosa, Leyte (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱8,196.00 worth of assistance was provided by **DSWD** to the affected family (see Annex D).
