

DSWD DROMIC Terminal Report on the Fire Incident in Brgy. 10 (Poblacion), Bacolod City

28 January 2025, 6PM

I. Situation Overview

On 26 June 2024 at around 12:30 AM, a fire incident occurred in Brgy. 10 (Poblacion), Bacolod City, Negros Occidental. The fire was declared out at around 2:55 AM.

In response, the DSWD through its Field Office in Region VI, together with the Local Government Unit (LGU) of Bacolod City, Negros Occidental, provided relief and financial assistance to support the immediate needs of the affected families.

II. Status of Affected Areas and Population

A total of **31 families** or **108 persons** were affected in **Brgy. 10 (Poblacion), Bacolod City, Negros Occidental** (see Annex A).

III. Status of Displaced Population

Inside Evacuation Center

A total of **31 families** or **108 persons** sought temporary shelter at the **Brgy. Hall** in **Brgy. 10 (Poblacion), Bacolod City, Negros Occidental** (see Annex B).

IV. Damaged Houses

A total of **18 houses** were damaged; of which, **15** are **totally damaged** and **three (3)** are **partially damaged** in **Brgy. 10 (Poblacion), Bacolod City, Negros Occidental** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱377,607.28** worth of assistance was provided to the affected families composed of **₱284,607.28** from **DSWD** and **₱93,000.00** from the **Local Government Unit (LGU)** (see Annex D).
