

# DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Anahawan, Bato, Leyte

29 July 2024, 6AM

## I. Situation Overview

On June 28, 2024, at around 6:05 AM, a fire occurred in Barangay Anahawan, Bato, Leyte, damaging eight (8) residential houses. Families affected sought refuge with relatives.

In response, the Department of Social Welfare and Development (DSWD) through its Field Office in Region VIII promptly provided relief and financial assistance to support the immediate needs of the affected residents.

## II. Status of Affected Areas and Population

A total of **eight (8) families** or **28 persons** were affected in **Brgy. Anahawan, Bato, Leyte** (see Annex A).

## III. Status of Displaced Population

### Outside Evacuation Center

A total of **eight (8) families** or **28 persons** temporarily stayed with their relatives or friends (see Annex B).

## IV. Damaged Houses

A total of **eight (8) houses** were damaged; of which, **five (5)** are **totally damaged** and **three (3)** are **partially damaged** in **Brgy. Anahawan, Bato, Leyte** (see Annex C).

## V. Cost of Humanitarian Assistance Provided

A total of **₱133,210.70** worth of assistance was provided by **DSWD** to the affected families (see Annex D).
