

DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Bagtic, Mabinay, Negros Oriental

31 January 2025, 6AM

I. Situation Overview

On 22 March 2024 at around 3:00 PM, a fire incident occurred at Sitio Mampalasan, Brgy. Bagtic, Mabinay, Negros Oriental. The fire was declared out at around 3:20 PM.

One (1) family or two (2) persons temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Bagtic, Mabinay, Negros Oriental** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱7,285.00** worth of assistance was provided to the affected family; of which, **₱1,330.00** from **DSWD** and **5,955.00** from the **Local Government Unit (LGU)** (see Annex D).
