

DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Culianan, Zamboanga City

17 May 2025, 6PM

I. Situation Overview

On 31 May 2024 at around 1:30 PM, a fire incident occurred at Zone V, Brgy. Culianan, Zamboanga City.

In response, the DSWD through its Field Office in Region IX, promptly provided relief assistance to support the immediate needs of the affected families and individuals.

A total of **20 families** or **100 persons** were affected in **Brgy. Culianan, Zamboanga City** (see Annex A).

III. Status of Displaced Population

Inside Evacuation Center

A total of **20 families** or **100 persons** sought temporary shelter at the **Familia Drive Vacant Lot** in **Brgy. Culianan, Zamboanga City** (see Annex B).

IV. Damaged Houses

A total of **17 houses** were damaged; of which, **14** are **totally damaged** and **three (3)** are **partially damaged** in **Brgy. Culianan, Zamboanga City** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱96,790.00** worth of assistance was provided by **DSWD** to the affected families (see Annex D).
