

DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Fusina, Lal-lo, Cagayan

30 January 2025, 6PM

I. Situation Overview

On 17 May 2024 at around 9:30 AM, a fire incident occurred in Brgy. Fusina, Lal-lo, Cagayan, causing partial damage to one (1) residential house. The affected family is now living in a temporary shelter provided by the Lal-lo Local Government Unit (LHU), awaiting the reconstruction of their home.

Relative to the incident, the DSWD through its Field Office in Region II, together with the Local Government Unit (LGU) of Lal-lo, Cagayan, provided relief and financial assistance to support the immediate needs of the affected family.

II. Status of Affected Areas and Population

One (1) family or six (6) persons were affected in Brgy. Fusina, Lal-lo, Cagayan (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or six (6) persons are temporarily staying in a makeshift shelter provided by the Local Government Unit of Lal-lo (see Annex B).

IV. Damaged Houses

One (1) house was partially damaged in Brgy. Fusina, Lal-lo, Cagayan (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **P47,852.20** worth of assistance was provided to the affected family composed of **P27,852.20** from **DSWD** and **P20,000.00** from the **Local Government Unit (LGU)** (see Annex D).
