

DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Lumbangan, Mabinay, Negros Oriental

18 February 2025, 6PM

I. Situation Overview

On 16 February 2025 at around 9:33 PM, a fire incident occurred in Brgy. Lumbangan, Mabinay, Negros Oriental. The fire was declared out at around 10:14 PM.

II. Status of Affected Areas and Population

One (1) family or seven (7) persons were affected in Brgy. Lumbangan, Mabinay, Negros Oriental (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or **seven (7) persons** temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house was totally damaged in Brgy. Lumbangan, Mabinay, Negros Oriental (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱12,285.00 worth of assistance was provided to the affected family; of which, ₱1,330.00 from the Department of Social Welfare and Development (DSWD) and ₱10,955.00 from the Local Government Unit (LGU) (see Annex D).
