

# DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Martilo, La Libertad, Negros Oriental

30 January 2025, 6AM

## I. Situation Overview

On 02 March 2024 at around 10:00 AM, a fire incident occurred at Brgy. Martilo, La Libertad, Negros Oriental. The fire was declared out at around 10:44 AM.

**One (1) family or seven (7) persons** temporarily stayed with their relatives or friends (see Annex B).

## IV. Damaged Houses

**One (1) house** was **totally damaged** in **Brgy. Martilo, La Libertad, Negros Oriental** (see Annex C).

## V. Cost of Humanitarian Assistance Provided

A total of **₱34,158.50** worth of assistance was provided to the affected family; of which, **₱6,158.50** from **DSWD** and **₱28,000.00** from the **Local Government Unit (LGU)** (see Annex D).
