

DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Sabangan, Binmaley, Pangasinan

29 July 2024, 6AM

I. Situation Overview

On 06 June 2024 at around 5:00 PM, a fire incident occurred at Sitio Bagong Barrio Sagur, Brgy. Sabangan, Binmaley, Pangasinan.

In response, the DSWD through its Field Office in Region I, together with the Local Government Unit (LGU) of Binmaley, Pangasinan, provided relief and financial assistance to support the immediate needs of the affected family.

II. Status of Affected Areas and Population

One (1) family or **five (5) persons** were affected in **Brgy. Sabangan, Binmaley, Pangasinan** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or **five (5) persons** temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was **totally** damaged in **Brgy. Sabangan, Binmaley, Pangasinan** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱21,867.80** worth of assistance was provided to affected family composed of **₱11,867.80** from **DSWD** and **₱10,000.00** from the **Local Government Unit (LGU)** (see Annex D).
