I. Situation Overview

On 02 April 2024 at around 3:00 PM, a fire incident occurred in Brgy. Samac, Mabinay, Negros Oriental. The fire was declared out at around 3:20 PM.

V. Cost of Humanitarian Assistance Provided

A total of ₱7,285.00 worth of assistance was provided to the affected person; of which, ₱1,330.00 from DSWD and ₱5,955.00 from the Local Government Unit (LGU) (see Annex D).
