

DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Ticad, Bantayan, Cebu

30 January 2025, 6AM

I. Situation Overview

On 21 March 2024 at around 6:42 PM, a fire incident occurred in Brgy. Ticad, Bantayan, Cebu. The fire was declared out at around 9:30 PM.

II. Status of Affected Areas and Population

A total of **seven (7) families** or **25 persons** were affected in **Brgy. Ticad, Bantayan, Cebu** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

A total of **seven (7) families** or **25 persons** temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

A total of five (5) houses were damaged; of which, three (3) are totally damaged and two (2) are partially damaged in Brgy. Ticad, Bantayan, Cebu (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱65,719.60 worth of assistance was provided to the affected families; of which, ₱47,736.00 from DSWD and ₱17,983.60 from the Local Government Unit (LGU) (see Annex D).
