I. Situation Overview

On 15 March 2024 at around 11:00 AM, a fire incident occurred in Sitio Polog, Brgy. Samac, Mabinay, Negros Oriental. The fire was declared out at around 11:05 AM.

One (1) family or two (2) persons temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Samac, Mabinay, Negros Oriental** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱7,285.00 worth of assistance was provided to the affected family; of which, ₱1,330.00 from DSWD and ₱5,955 from the Local Government Unit (LGU) (see Annex D).
