

DSWD DROMIC Report #1 on the Fire Incident in Brgy. Balite, Aritao, Nueva Vizcaya as of 05 July 2024, 6AM

I. Situation Overview

On 30 June 2024 at around 4:00 PM, a fire incident occurred in Brgy. Balite, Aritao, Nueva Vizcaya.

II. Status of Affected Areas and Population

One (1) family or **seven (7) persons** are affected in **Brgy. Balite, Aritao, Nueva Vizcaya** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

There is **one (1) family** or **seven (7) persons** temporarily staying with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Balite, Aritao, Nueva Vizcaya** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱36,570.28** worth of assistance was provided to the affected family; of which, **₱25,270.28** from **DSWD** and **₱11,300.00** from the **Local Government Unit (LGU)** (see Annex D).
