

DSWD DROMIC Report #1 on the Fire Incident in Brgy. Ginatilan, Balamban, Cebu as of 05 July 2024, 6PM

I. Situation Overview

On 05 June 2024 at around 2:00 PM, a fire incident occurred in Brgy. Ginatilan, Balamban, Cebu. The fire was declared out at around 2:10 PM.

II. Status of Affected Areas and Population

A total of **two (2) families** or **six (6) persons** are affected in **Brgy. Ginatilan, Balamban, Cebu** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

There are **two (2) families** or **six (6) persons** temporarily staying with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Ginatilan, Balamban, Cebu** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱22,465.00** worth of assistance was provided to the affected families; of which, **₱10,865.00** from **DSWD**, **₱6,600.00** from the **Local Government Unit (LGU)**, and **₱5,000.00** from **Other Partners** (see Annex D).
