





DSWD DROMIC Report #2 on the Fire Incident in Brgy. Camino Nuevo, Zamboanga City

as of 28 July 2024, 6PM

I. Situation Overview

On 26 July 2024 at around 4:40 PM, a fire incident occurred at Calle Punta, Brgy. Camino Nuevo, Zamboanga City.

II. Status of Affected Areas and Population

A total of **281 families** or **858 persons** are affected in **Brgy. Camino Nuevo, Zamboanga City** (see Annex A).

III. Status of Displaced Population

Inside Evacuation Center

There are **281 families** or **858 persons** currently taking temporary shelter at a **Covered Court** in **Brgy. Camino Nuevo, Zamboanga City** (see Annex B).

IV. Damaged Houses

A total of 133 houses were damaged; of which 129 are totally damaged and four (4) are partially damaged in Brgy. Camino Nuevo, Zamboanga City (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱692,732.00 worth of assistance was provided by DSWD to the affected families (see Annex D).
