

DSWD DROMIC Report #6 on the Fire Incident in City Proper, Iloilo City as of 09 July 2024, 6AM

I. Situation Overview

On 17 June 2024 at around 2:00 AM, a fire incident occurred at the boundary of Brgy. Tanza Bonifacio and Brgy. Rizal Estanzuela, City Proper, Iloilo City. The fire was declared out at around 4:37 AM.

II. Status of Affected Areas and Population

A total of **88 families** or **293 persons** are affected in **two (2) barangays** in **City Proper, Iloilo City** (see Annex A).

III. Status of Displaced Population

Inside Evacuation Center

A total of **88 families** or **293 persons** sought temporary shelter in **two (2) evacuation centers** in **City Proper, Iloilo City** (see Annex B).

IV. Damaged Houses

A total of **50 houses** were damaged; of which, **34** are **totally damaged** and **16** are **partially damaged** in **City Proper, Iloilo City** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱1,984,184.94** worth of assistance was provided to the affected families; of which, **₱1,297,937.44** from **DSWD**, **₱634,247.50** from the **Local Government Unit (LGU)**, and **₱52,000.00** from **Other Partners** (see Annex D).
